

STATE AFFILIATION AGREEMENT (SAA)

Impact of Disaffiliation on State Affiliate and SNA Members

In May 2017, SNA introduced a State Affiliation Agreement (SAA) to state leaders to outline the roles and responsibilities of both SNA and the state affiliates, documenting the current relationship. While most state associations have been affiliates of SNA for almost 70 years, there was no formal agreement to clarify the relationship for national and state volunteer leaders. As of August 15, 2018, 44 of 49 states affiliates have signed the agreement.

The SNA Board of Directors' goal is to maintain a strong and united national association to represent the 57,000 plus professionals working in school nutrition programs, so we can work together to face the Federal funding challenges that lie ahead for school nutrition programs and protect the programs for the students our members feed every day.

At the July ANC SNA Board of Directors meeting, the Board discussed and approved maintaining the deadline for signing the SAA of December 31, 2018 that was announced in May 2017. In addition, the Board approved sharing with all state affiliates, the impacts if a state affiliate chooses not to sign the SAA and maintain its affiliation with SNA. It is SNA's hope that the remaining state affiliates recognize the mutually beneficial relationship and the valuable benefits that would no longer be available to state SNA members or the state

affiliate organization. While SNA members will be able to retain their SNA membership as direct national members, there are impacts on full membership benefits as a result of not being a SNA state affiliate member. State organizations would be significantly impacted.

With only four and a half months to go before the deadline, SNA hopes the remaining unsigned state affiliate boards of directors are discussing this important decision and will make a choice in the best interest of members to stand strong with SNA.

The list below outlines impacts that a current state affiliate or SNA member in their state would experience if the state affiliate choose not to remain a SNA affiliate.
